Anti Ragging Report

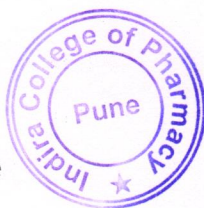

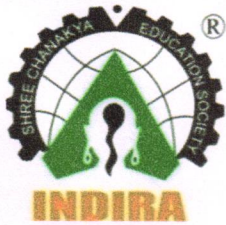

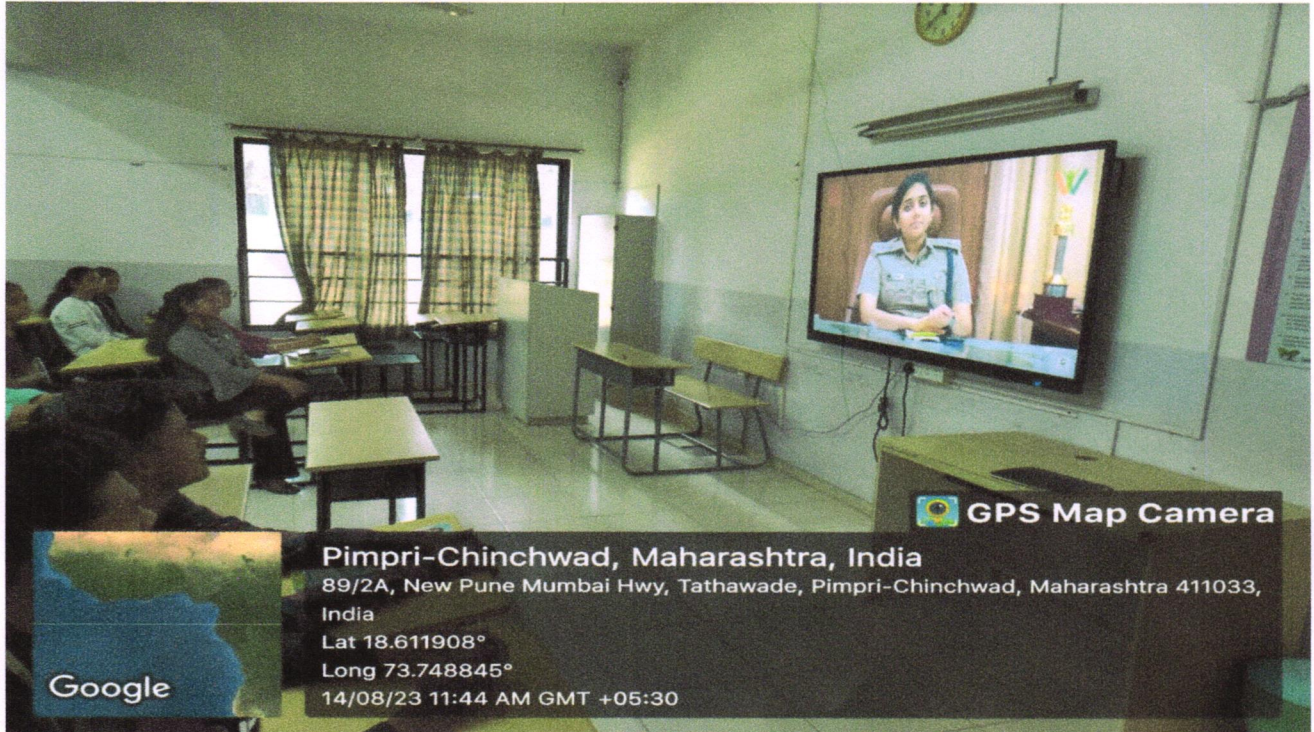
