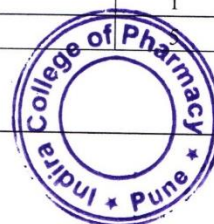

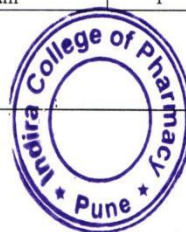

3. Animal House Facility:

- The institute has a state-of-art animal house and has build-up area of 80.85 sq mt. Animal house is well-ventilated and is maintained in accordance with CPCSEA guidelines.
- Different sections are constructed in animal house as per the CPCSEA guidelines viz. instruction room, quarantine section, store room, surgical room, Breeding Section, Animal stock room, experimental room and Cleaning area.
- Institutional Animal Ethical Committee is formed according to CPCSEA guidelines to monitor the learning and research activities. CPCSEA has approved the animal house facility for experimentation (Reg. no. : 1265/PO/Re/S/09/CPCSEA) under The Committee for the Purpose of Control and Supervision of Experiments on Animals(CPCSEA) is a statutory Committee, which is established under Chapter 4, Section 15(1) of the Prevention of Cruelty to Animals Act 1960.
- The animal house has facility to house rats, mice and rabbits. For each species of animals individual rooms are available to avoid disease transmission and inter-species conflicts.
- The animal rooms are supplied with fans and air conditioning for fresh air exchange in animal rooms with sufficient lighting and uninterrupted power and water supply.
- The animal house facility boosts the academic and research environment in the emergent fields of experimental pharmacology, molecular biology and toxicology. The facility is dedicated to provide healthy laboratory animals and to assist the investigators with ethical usage of animals for their research while maintaining compliance with the CPCSEA. Qualified members of faculty are always at hand to help in research and keep it following the standards established by CPCSEA. The Animal house provides pre-clinical testing in conformity with national and international regulatory guidelines.
