❖ Polio Vaccination Campaign

- Polio, the deadly viral disease that was once the leading cause of paralysis among children worldwide, is very close to being eradicated. Since 1988, the number of children affected by polio has reduced by 99 percent. To eliminate polio completely, every child in every household must be vaccinated. But thousands of children are still missing out on the polio vaccine. The Indian government is taking efforts for so many years to eradicate polio by conducting a polio vaccination campaign every year.
- This year polio vaccination campaign was conducted from 27th March to 3rd April 2022 by PCMC hospital. The training for the campaign was held one week prior to train students about the proper storage of polio vaccines and the proper way of administering the vaccine to children by PCMC staff.
- The vaccination drive was started on 27th March 2022. The number of students who participated in the polio vaccination campaign was around 80. The student went to their destination on time as advised by their supervisor from PCMC on the first day itself. They reached every doorstep having a child below 5 years. Many of these children living in remote, fragile, and conflict-affected areas, which makes reaching them with vaccines even more difficult, were also tapped by students from Indira College of Pharmacy, Pune.
- The students were offered breakfast and commute facilities on all the days of the polio vaccination campaign by PCMC hospital. The enthusiasm went high till the last date of vaccination. Almost every area in PCMC was covered by students not to miss out on any children below age 5.
- The students also received remuneration and a certificate from PCMC for participating in polio vaccination campaign.
